## **Building (Product Recognition WaterMark Water Closet Pans) Notice 2026: RN-10023**

### **1 Title**

This is the Building (Product Recognition WaterMark Water Closet Pans) Notice 2026: RN-10023.

### **2 Commencement**

This notice comes into force on 9 February 2026.

### **3 Interpretation**

In this notice of recognition, unless the context otherwise requires,—

*Act* means the Building Act 2004

*Building Code* means the New Zealand Building Code, which is Schedule 1 of the Building Regulations 1992, made under section 400 of the Act.

*Certified intended use* means the intended use of the building product certified by the certification body and as described in either the product certificate, building product's manual, or other relevant materials.

*Conformity assessment body (CAB)* means an organisation that certifies activities to demonstrate that a product, process, system, person, or body meets specified requirements for the WaterMark certification scheme.

*Product type* means a plumbing or drainage product that presents a public risk requiring mitigation, as determined by the Protocol for the Assessment of Risks of Plumbing Product under the WaterMark scheme. It is regulated under the Plumbing Code of Australia and listed in the WaterMark Schedule of Products.

### **4 Recognition of the following certified WaterMark products**

Under section 272HA of the Act, I recognise the building products certified under the overseas product certification scheme, WaterMark, that are included in the product certificates listed in Schedule 1 of this notice.

### **5 Certified intended use of building product**

The certified intended use of the product types listed in Schedule 1 of this notice are the product scope/applications of the product type categories under the WaterMark certification scheme, known as the WaterMark Schedule of Products – Sanitary fixtures.

**Water closet:** Pans intended for use with flushing cisterns and other flushing devices, including mains and break tank supplied flushing valves.

### **6 Conditions and limitations of this notice**

The conditions and limitations of this recognition notice are set out in Schedule 1.

Empowering Act and provisions	<p><b>Building Act 2004</b></p> <p><i>Section 272HA Recognition of building products or building methods certified under overseas product certification scheme</i></p> <p>(1) The chief executive may, by notice, recognise 1 or more, or 1 or more groups of, building products or building methods that are certified under an overseas product certification scheme.</p> <p>(2) Subsection (1) applies only if the chief executive is satisfied that—</p> <ul style="list-style-type: none"><li>(a) the building products or building methods meet any criteria prescribed for the purposes of this paragraph; and</li><li>(b) the overseas product certification scheme meets any criteria prescribed for the purposes of this paragraph.</li></ul> <p>(3) A person who uses building products or building methods that are (or are in a group that is) recognised under subsection (1) must, for the purposes of this Act, be treated as having complied with all provisions of the building code that are relevant to the intended use.</p> <p>(4) Subsection (3) applies only to the extent that the person complies with any limitations or conditions of the recognition that are set out in the notice.</p> <p>(5) A notice under subsection (1) is secondary legislation (see Part 3 of the Legislation Act 2019 for publication requirements).</p>
