This notice is made under section 272HA of the Building Act 2004 by Simon Thomas, Head of Building System Delivery and Assurance at the Ministry of Business, Innovation and Employment (MBIE), under the delegated authority of MBIE's Chief Executive.

This notice recognises building products specified in the product certificates in Schedule 1 of this notice, which are certified under the WaterMark certification scheme in Australia.

## **Building (Product Recognition WaterMark Appliances, Low Hazard Rating) Notice 2026: RN-10055**

### **1 Title**

This is the Building (Product Recognition WaterMark Appliances, Low Hazard Rating) Notice 2026: RN-10055.

### **2 Commencement**

This notice comes into force on 9 February 2026.

### **3 Interpretation**

In this notice of recognition, unless the context otherwise requires,—

*Act* means the Building Act 2004

*Building Code* means the New Zealand Building Code, which is Schedule 1 of the Building Regulations 1992, made under section 400 of the Act.

*Certified intended use* means the intended use of the building product certified by the certification body and as described in either the product certificate, building product's manual, or other relevant materials.

*Conformity assessment body (CAB)* means an organisation that certifies activities to demonstrate that a product, process, system, person, or body meets specified requirements for the WaterMark certification scheme.

*Product type* means a plumbing or drainage product that presents a public risk requiring mitigation, as determined by the Protocol for the Assessment of Risks of Plumbing Product under the WaterMark scheme. It is regulated under the Plumbing Code of Australia and listed in the WaterMark Schedule of Products.

### **4 Recognition of the following certified WaterMark products**

Under section 272HA of the Act, I recognise the building products certified under the overseas product certification scheme, WaterMark, that are included in the product certificates listed in Schedule 1 of this notice.

### **5 Certified intended use of building product**

The certified intended use of the product types listed in Schedule 1 of this notice are the product scope/applications of the product type categories under the WaterMark certification scheme, known as the WaterMark Schedule of Products – Appliances.

*Clothes washing machines:* Commercial.

*Dish washing machines:* Commercial.

*Pot washing machines:* Commercial.

*Fruit/vegetable peelers:* Commercial.

*Glass washing machines/Milk jug rinsers:* Commercial.

**Chemical dispensers:** Non-portable dispensing units, or portable dispensing units (ie hand held) with an end of line backflow prevention device, not intended to directly supply drinking water, considered a low risk of back siphonage, connected to the water service and/or sanitary plumbing/drainage system.

**Steamers:** Steamers not intended to directly supply drinking water, considered a low risk of back siphonage, connected to the water service and/or sanitary plumbing/drainage system.

**Steam generators:** Steam generators for the warming of a steam room to a bathing temperature. This may include a sauna.

**Humidifiers:** Humidifiers not intended to directly supply drinking water, considered a low risk of back siphonage, connected to the water service and/or sanitary plumbing/drainage system.

**Water doser mixers:** Appliance to dose a specific volume and temperature of water in commercial bakery applications.

**Pedicure foot spas:** Appliance to deliver tempered water to a receptacle for foot washing and/or hydromassage.

## 6 Conditions and limitations of this notice

The conditions and limitations of this recognition notice are set out in Schedule 1.
