This National Multiple-Use Approval is subject to the following conditions:

- 1. This National Multiple-Use Approval may only be used in its entirety, and does not apply to any one part of the plans and specifications.
- 2. Minor Customisations to the design, as defined in the Building (Minor Customisations) Regulations 2024, are permitted; and must be assessed when applying for a building consent or an amendment to a building consent.
- 3. If there are any changes, other than Minor Customisations and Permitted Variations, to the approved plans and specifications then this National Multiple-Use Approval does not apply.
- 4. Mirror images and flipped or handed images of the floor plan and roof plan are permitted.
- 5. This National Multiple-Use Approval can only be used where the following conditions apply:
 - a. Seismic zones: A, B, and C
 - b. Snow loading: 0.5Kpa maximum (open ground load)
 - c. Wind zones: Up to and including Very High
 - d. Climate zones: 1, 2, and 3*
 - e. Roofing finish: ColorCote ZMX or ZRX for sea spray zone (excludes geothermal hot spots)
 - f. Corrosion zone: Up to and including Sea spray (excludes geothermal hot spots)
