 - d. Climate zones: Up to and including Zone 3
 - e. Ground bearing capacity: Good ground as defined in B1 Structure Compliance Document
 - f. Exposure zone: Up to and including Zone D to NZS 3604:2011 except where adverse microclimatic factors (e.g. geothermal)
