  - c. Wind zones: Limited to sites with an Ultimate Wind Speed of 44m/s (High) as defined in NZS 3604:2011
  - d. Climate zones: Up to and including Zone 3 as defined in NZS 4218:2009
  - e. Ground bearing capacity: Good ground as defined in B1 Structure Compliance Document
  - f. Exposure zone: Up to and including Zone D as defined in NZS 3604:2011, except where adverse microclimatic factors (e.g. geothermal)
  - q. The building must be connected to a potable water supply (for compliance with G12) and to a sewer or on-site foul water disposal system (for compliance with G13)
