 - e. Climate zone: Limited to sites up to and including Zone 2 as defined in Appendix B of NZS 4218:2009
 - f. Snow Loading: Limited to a maximum 1kPa ground snow load as defined in NZS 3604; 2011.
 - g. Ground bearing capacity: Good ground as defined in B1 Structure Compliance Document
