- 3. If there are any changes to the approved plans and specifications this National Multiple-Use Approval does not apply.
- 4. Minor variations to the design as defined in the Building (Minor Variations) Regulations 2009 are permitted; and must be assessed at the building consent stage.
- 5. Foundations are not included in this National Multiple-Use Approval.
- 6. Protection from Fire and Accessibility are not included in this National Multiple-Use Approval to be assessed as part of the application for building consent (including any compliance schedule requirements).
- 7. M.o.E. requirements have not been assessed as part of this National Multiple-Use Approval.
- 8. This National Multiple-Use Approval can only be used where the following conditions apply:
  - a. Wind zone: Limited to sites up to and including Very High wind zone excluding lee zones as defined in NZS 3604:2011.
  - b. Seismic zone: Limited to sites up to and including Earthquake zone 3 and in all subsoil classes as defined in NZS 3604:2011.
  - c. Exposure zone: Limited to sites up to and including Zone D as defined in NZS 3604:2011. Excludes all microclimatic conditions.
  - d. Climate zone: Limited to sites up to and including Zone 4 as defined in H1/AS1
