## **Background**

- The designer described above (Designer) has been commissioned to prepare the design, plans and specifications for the homeowner described above (Homeowner). The design, plans and specifications describe certain works to be carried out on the property described above (Property). Those works are required as a result of the Property not being weathertight.
- The Homeowner wishes to receive payments from the Government (acting by and through the Ministry of Business, Innovation & Employment) (Ministry) and the council described above (Council) to pay for part of the cost of making repairs to the Property to remedy problems arising from the Property not being weathertight. The Homeowner has entered into a homeowner agreement with the Ministry and the Council (Homeowner Agreement).
- Pefore the Homeowner can receive any payment from the Ministry and/or the Council under the Homeowner Agreement, the Homeowner has had to satisfy a number of criteria and obtain the Ministry's approval to a number of requirements. In order to satisfy one of those requirements, the Homeowner will need to submit a designer's statement confirming certain things.
- This statement is the 'Designer's Statement' that the Homeowner needs to submit to the Ministry and the Council under the Homeowner's Homeowner Agreement.
- The Designer should be aware of and have the necessary expertise to address the particular repair issues arising out of a property not being weathertight.
