

## F1 Hazardous agents on site

---

### Identifying and neutralising any hazardous agents or other contamination of the building site.

This clause safeguards people from injury or illness caused by hazardous agents or contaminants on a site.

It sets out assessment and performance requirements that account for the intended use of the building, the nature, potency and toxicity of hazards and contaminants, and any protection afforded by the building envelope and building systems.

### 2015/050: Regarding the refusal to issue a code compliance certificate for a 19 year-old house with a 14 year-old addition

---

<p>This determination considers the compliance of the building work in light of a refusal to issue a code compliance certificate; the refusal was primarily on the grounds of concerns regarding weathertightness and durability of the exterior cladding given the building's age and its history.</p>
